Explosion protected installation switches, type SKX-SW/1, SKX-SW/2, SKX-SW/6 are use for on and off light circuits up to 16A in industrial with potentially explosive atmosphere in Zones 1, 2 accordance with EN 60079-10-1:2009.

### 4. PRODUCT COMPLIANCE

The product is accordance with the standards EN 60598-1:2008 and related standards.

The product is in compliance with Regulations concerning equipment and protective systems for use in potentially explosive atmosphere.




1. On-off switch 1 pole

6. Two-way switch








# 10. MOUNTING

Montage of installation switches is performed by fixing on a flat surface or wall with screw accessories in the tops of the rectangle at given dimensions:

With the introduction of armored cables you need to connect an external ground wire to a metal glands and internal ground of the metal introducer to the PE terminal inside the case.

# 12. INSPECTION, MAINTENANCE, REPAIR AND OVERHAUL

Inspections are carried out in accordance with IEC 60079-17:2014, general and special conditions of manufacturer and users Regulations and includes supervision of parts on which the explosion protection depends, especially:

- that the housing and all part of housing without repture and demage,
- that the gasket of cover is undamaged and cover screw are fastened with nominal torque,
- that the actuators and indicators are undemage and enough fixed for housing and cover and gaskets are undemage,
- that the screw of terminal pushbutton, nut of operation heads, cable glands and plugs are fastened with nominal torque,.

All the repairs are performed by the manufacturer or the manufacturer's authorized personal and the original parts must be provided according to the product documentation, all in accordance with EN 60079-19:2011.

If repair or any other procedure are performed on the product by unauthorized person, all producer responsibility for the product and the warranty and the manufacturer's declaration of conformity becomes invalid.

#### 13. RESPONSIBILITY AND AUTHORIZATION

This instruction is the basic information about the product. It is completed by the corresponding national laws and regulations. Production, use, certification and supervision are determined at the national level:

- a) Regulations concerning equipment and protective systems intended for use in potentially explosive atmospheres EU directive 94/9 EC (ATEX 95)
- b) Regulations on minimum requirements for safety and health protection of workers and technical inspection of facilities, equipment, installations and equipment in hazardous areas EU directive 1999/92/EC (ATEX 137).

The responsible person shall ensure their implementation at the working facility.

# 14. STORAGE AND TRANSPORT

Transportation and warehousing of the lamps is only allowed in the original packaging, as outlined in a cardboard box.
